

PRIVACY STATEMENT

In order to use Paws & Minds services information is collected about you and your needs. It is important for you to understand what information is collected and how that information is used. You will be asked to provide Paws & Minds with information prior to using dog training and behaviour advice services. Paws & Minds services are subject to this Privacy Statement and Terms and Conditions (see separate document).

DATA COLLECTED

Personal information collected about you is the information you provide when completing a registration form. This typically comprises; your name, address, contact details (phone number/email address), and any information you have provided about your pet such, e.g. training and behaviour needs, health conditions and allergies. By providing this information you will be deemed to have consented to the collection of such information. Paws and Minds data collection complies with The Data Protection Act 1998.

If you have provided any information for a third party (e.g. emergency contact) ensure that you have their consent to do so. USE OF PERSONAL INFORMATION
